FOREIGN WORKERS MEDICAL INSURANCE

We offer Foreign Workers Medical (FWM) Insurance which is underwritten by AXA Insurance Pte Ltd, Liberty Insurance Pte Ltd and Tokio Marine Insurance Singapore Ltd. These insurers have extended to cover COVID-19 medical expenses incurred for hospitalization treatment for your foreign workers (Work Pass In-Principle Approval (IPA), valid Work Permit and S Pass holders) within 14 days of arrival in Singapore. Insurance must be purchased before your workers arrive in Singapore and administered on a named basis.

AXA Insurance Pte Ltd

Covers for COVID-19 hospitalization treatment in Singapore from Day 1 of the foreign worker's arrival in Singapore on or after 1 January 2021 at no extra premium as long as there is a primary AXA FWM insurance policy in place with continuous cover. This is up to the policy limits under the current policy terms and conditions. Employer must declare the date of arrival of the foreign worker(s) prior to their arrival in Singapore. Any mandatory tests for COVID-19, swab tests and charges relating to Quarantine or Stay-Home-Notice (SHN) facilities are excluded.

Liberty Insurance Pte Ltd

Covers up to S\$15,000 for COVID-19 hospitalization treatment in Singapore Government/Restructured Hospitals. Cover will cease automatically if the worker is not diagnosed with COVID-19 within 14 days after the date of arrival in Singapore. Cost incurred for Stay-Home-Notice (SHN)/quarantine or swab tests are not covered.

FWM (COVID-19) covers up to S\$15,000 hospitalization costs in Singapore Government/Restructured Hospitals (4-bed or lower) if the insured worker is diagnosed with COVID-19 during their Stay-Home-Notice (SHN) period/14 days upon arrival. Cost of swab tests, quarantine and isolation facilities are not covered.
